Dear Sir,

Our client: Magicalia Limited

We act for Magicalia Limited. Our client has recently learnt of your unauthorised scanning and uploading of materials from the magazines, Model Engineer and Model Engineers' Workshop (the "Magazines"), onto various Yahoo user groups set up by you. We attach a non-exhaustive list of the Yahoo user groups in question.

We comment as follows:

1. Our client is the publisher of the Magazines and is the owner of the copyright in all materials contained in the Magazines.
2. We have advised our client that any unauthorised copying of materials taking from its magazines amounts to a blatant infringement of copyright.
3. Our client is not prepared to permit the continued infringement of its intellectual property rights. We have advised our client that under US copyright law, specifically The Digital Millennium Copyright Act 1998, our client can inform Yahoo of the infringement of its copyright and instruct them to remove the infringing material.
4. We have also advised our client that it has the right to commence proceedings against you for copyright infringement to obtain damages and the costs of bringing such an action could of course be substantial.
5. In an effort to resolve this issue without involving Yahoo or recourse to litigation, our client will not contact Yahoo or take proceedings against you if, by no later than, close of business on 19 January 2007 you have removed all the materials that you have scanned and uploaded onto Yahoo user groups from the Magazines.
